

Requirements for Non Profit Raffles Limited to Boulder City

1. We must have a completed Special Event Permit-Gambling application.
2. Applicant must have a Non-Profit Permit on file with the City.
 - A. Proof of Non-Profit Status from IRS
 - B. Copy of Articles of Incorporation
 - C. Financial Statement
 - D. Breakdown of Funds
3. If they are requesting something that does not fall under the guidelines of City Code 4-4, then the Licensing Board (City Manager, City Attorney, and City Clerk) must grant special approval.
4. They must contact the State Gaming Control Board and comply with the items listed below under “State of Nevada”.

Requirements for Non Profit Raffles where ticket sales are NOT limited to Boulder City

1. Must have all of the above plus:

State of Nevada requires: (486-2020-Marina Vince)

1. If the value of the item raffled is less than \$2,500 – nothing is required.
2. If the value of the item raffled is between \$2,500 to \$25,000:

A. Need to Register with the state of Gaming Control Board

1. Complete State application
 2. Provide proof of non-profit status
 3. Cost of \$5.00
 4. Can only do 1 raffle per quarter
 5. All funds raised must stay in-state
 6. Tickets can only be sold in Clark and adjacent County
1. If the value of the item raffled is more that \$25,000:
 1. Complete State application
 2. Provide proof of non-profit status
 3. Need State Board Approval
 4. Costs of \$25.00
 5. At the completion of the event, must provide a financial statement itemizing raffle cost and profit.
